1) Introduction

The regulation that applies to UK businesses is the UK General Data Protection Regulation (UK GDPR) and this is tailored by the Data Protection Act (DPA) 2018.

Thorne ETS is registered with, and supervised by, the information Commissioner's Office (ICO) for the purposes of Data Protection.

2) Website Hosting and Security - SSL Certificate

This website is hosted by Hosted Desktop UK and is protected by a Secure Sockets Layer (SSL) Certificate. SSL is the standard security technology for establishing an encrypted link between a web server and a browser. This link ensures that all data passed between the web server and browser remains private. This means that you can use this site knowing that it is secure. You can see this by looking at the address bar in your browser; there will be a padlock in front of the address to show that it is secure.

3) What information do we collect about you?

When using this site you are not required to provide any personal information. If you decide to contact us and provide personal information such as your name, email address or telephone number or if you contact us using the contact form, then you agree to us contacting you with regard to your enquiry. We will not retain this information unless you decide to become a client of Thorne ETS.

This personal information will be used solely by Thorne ETS. It will not be used for marketing purposes, sold, leased or transferred to any other third parties without your express consent or unless required by law.

4) Information we monitor about visitors to this website

When you visit our website "cookies" are downloaded onto your computer. Most websites now use cookies to ensure that the website operates correctly and optimally and also to help website owners understand how visitors interact with their website by collecting and reporting information anonymously.

5) Cookies

A cookie is a small text file that is downloaded onto a computer or smartphone when a user accesses a website. It allows the website to recognise that user's device and store some information about the user's preferences or past actions.

Cookies cannot identify you and you can remove or reject cookies by changing the settings in your browser.

Thorne ETS does not use cookies for marketing, advertising or profiling.



The first time that you visit our website you will be given the option to consent to allow cookies to be stored on your device.

6) Google Analytics

Thorne ETS also use Google Analytics to analyse the traffic to our site, to see how our site is used and to enable us to measure and improve the performance of our site.

Google Analytics is a web analysis service provided by Google. All data collected by these cookies are aggregated and therefore anonymous. No individual visitors may be personally identified by Thorne ETS or by Google.
